

General Terms and Conditions for participation in the ADAC Campcard System of ADAC Camping GmbH in 2022 - Status June 2021

By participating in the ADAC Campcard System, you, as the operator of the campsite or pitch, agree to the following terms and obligations.

General provisions:

to participate (for campsites and pitches)

- Participation in the ADAC Campcard system is free of charge.
- A discount is obligatory on at least 50 days per season, distributed over a maximum of 4 freely selectable offer periods per calendar year.
- Advance reservations must also be possible for ADAC Campcard holders.
- There is no entitlement to publication of the campsite operator's offer.
- In case of non-granting of the advantages assured for the ADAC Campcard, ADAC Camping GmbH reserves the right to exclude the operator concerned from ADAC Camping GmbH publications.

to the offer (for campsites)

- The offer is to be provided in the form of a percentage discount on the price of the overnight stay and is valid for guests from the 1st night.
- The offer is valid either for pitches or for self-catered rental accommodation, or both.
- The discount is granted in each case for all pitches and/or self-managed rental accommodation.
- The following percentage discount levels are available for selection
 - o **15%**
 - o **20%**
 - o **25%**
 - o **35%**
 - o **50%**
- Campgrounds may select a separate discount level per offer period.
- The discounted overnight rate includes at least the fees for the pitch rental and any

applicable fees for persons staying overnight thereon.

- Optional discounts "Children incl. 6 years stay free of charge" and "Dogs free of charge" can be offered.
- Extra services that go beyond this (e.g. electricity or showers) and are not included can optionally be additionally discounted with the same percentage. A publication of these additional discounts in the ADAC Camping | PiNCAMP products is not intended.

to the offer (for pitches)

- Pitch operators can choose one or more of the following options:
 - a discount level for the selected periods, provided that the pitch generally charges for the overnight stay
 - the discount "children incl. 6 years stay free of charge", if the pitch generally charges for children
 - the discount "dogs free of charge", if the pitch generally charges for dogs
 - o individual free services or benefits
- The following percentage discount levels are available for selection
 - o **15%**
 - o **20%**
 - o **25%**
 - o **35%**
 - o **50%**
- The discounted overnight rate includes at least the fees for the pitch rental and any applicable fees for persons staying overnight thereon.

Conditions for ADAC Campcard holders:

- The benefits apply to all holders of a valid ADAC Campcard (print/digital).
- The ADAC Campcard must be indicated for the reservation and presented at the beginning of the stay.
- The non-digital ADAC Campcard is only valid with full name and signature on the back.
- The digital ADAC Campcard of the ADAC Camping- und Stellplatz App requires the full name. It is non-transferable and valid for one calendar year (including January of the following year).
